→ 'Complete streets' bill picks up opposition heading into last week of Legislative session

Legislation long opposed by CalAPA, a so-called "complete streets" bill that seemingly repairs everything except roads, is picking up opposition heading into the final week of the Legislative session.

SB127, authored by state Sen. Scott Wiener, D-San Francisco, creates a mandate for Caltrans to include pedestrian, bicycle and other "active transportation" enhancements in projects funded out of the department's maintenance program. A Caltrans analysis of the bill has found the cost to the state if SB127 passes to be in the many millions, if not tens of millions of dollars.

CalAPA was one of the early opponents of the bill, and the association's opposition letter is quoted in the Legislature's floor analysis of the bill. The bill has passed the state Senate and is awaiting final approval in the Assembly. The author has taken CalAPA to task in media reports for its opposition.



"Your bill, aimed at the 'complete streets' concept of multimodal design, has merit and in fact is already the stated policy goal of Caltrans, and the department continues to make great strides in this area," the CalAPA opposition letter to Wiener states. "However, as written, your bill is overly restrictive and may hamper the ability of engineers to make prudent decisions on safety improvements on the state highway system. In short, in this matter we believe engineering decisions are best made by registered professional engineers and technical experts, validated by independent research and field-tested, rather than accomplished through Legislation."

The association also has expressed concern that the bill runs counter to the intent of SB1, the "Road Repair & Accountability Act of 2017," which was passed by the Legislature and later the subject of two ballot measures in 2018 to protect SB1 funds. Voters have been promised that raising state fuel taxes will be used to fix crumbling pavement and substandard bridges across the state. SB1 generates about \$5 billion per year for state and local transportation improvements.

An Assembly Appropriations Committee analysis notes that the ultimate cost of the bill is unknown, but "presumably (a) significant amount, likely in the range of millions of dollars to tens of millions of dollars annually."

"The bill makes no additional funding available for capital improvement projects and, despite recent increases in transportation funding made available by the Road Repair & Accountability Act of 2017, demand for capital improvement dollars outstrips supply," the analysis states.

Numerous SB1 coalition partners that lobbied for the original bill in the Legislature, and fought against repeal efforts last year, stepped up efforts last week to make their opposition known. The final day of the legislative session is Friday. Bicycle advocates, meanwhile, have issued a call to their members to contact their member of the Assembly urging a "yes" vote on SB127.



"It's almost across the finish line, but we'll need your help to put pressure on your elected officials," an alert from the California Bicycle Coalition stated.

Tennessee transportation executive named new director of Caltrans


Gov. Gavin Newsom last week named a transportation executive from Tennessee to take over the helm as director of the California Department of Transportation (Caltrans).

Adetokunbo "Toks" Omishakin, 43, has been deputy commissioner for environment and planning at the Tennessee Department of Transportation since 2011. His role also oversees transit programs for TennDOT.

Previously he was director of Healthy Living Initiatives in the Nashville's Mayor's Office, from 2008 to 2011.

Newsom also announced that James Davis, 54, of Davis, will serve as chief

deputy director for Caltrans. He has been special advisor to the director where, among other duties, he was overseeing the department's SB1 implementation. His official biography is [HERE](#).

Omishakin becomes the 10th Caltrans director in 10 years and will oversee a massively complex government agency of more than 20,000 employees and a \$15 billion budget. The department has been on a hiring spree since the passage of SB1, the Road Repair & Accountability Act of 2017, which has generated more than \$5 billion year for transportation improvements paid for by tax hikes on gasoline, diesel and vehicle registrations. Among Caltrans' responsibilities is maintenance of a 50,000 mile system of freeways and highways across the state.

"We look forward to working collaboratively with Toks Omishakin to improve transportation in California," said CalAPA Chairman Jordan Reed with George Reed Inc. "Tennessee, like California, recently enacted a gas-tax increase to support fixing roads and bridges, so he will be familiar with the challenge of converting tax dollars to road improvements quickly and efficiently in a manner that is most conspicuous to the traveling public. Also, his background in goods-movement will be valuable given California's prominent role as the gateway to the Pacific Rim."

In 2017, the Tennessee Legislature passed, and the governor signed into law, the "IMPROVE Act," which is an acronym for "Improving Manufacturing, Public Roads and Opportunities for a Vibrant Economy Act, meant to help pay for the state's \$10 billion backlog in road repairs. The legislation is estimated to provide \$250 million to the state Department of Transportation, \$70 million to counties and \$35 million to cities, according to news reports.

Omishakin is described by those who have worked with him as approachable and a good listener.


"The Tennessee Road Builders Association worked closely with Toks Omishakin during his tenure at the Tennessee Department of Transportation," Kent D. Starwalt, executive vice president of the association, told the *California Asphalt Insider*. "We have always found him to be bright, personable and always willing to listen to our concerns."
